In compliance with article 5 of the Regulation of the Dispute Settlement and Prevention Board ("Dispute Board") of Med Arb RB, the following costs related to the Dispute Settlement and Prevention Board of Med Arb RB payable to Med Arb RB, in force from 06/02/2023, are hereby established as follows:

2. In compliance with article 5 of the Regulation of the Dispute Settlement and Prevention Board ("Dispute Board") of Med Arb RB, the following costs related to the Dispute Settlement and Prevention Board of Med Arb RB payable to the Board Members, in force from 06/02/2023, are hereby established as follows:

Monthly Fees	BRL 4,000.00	Payable every month from the execution of the Term of Board Establishment until the end of the effectiveness of such Term. It shall be charged at a fixed date to be defined in the Term of Board Establishment. Monthly fees are payable for each one of the Members.
Daily Fees	BRL 3,000.00	Payable at every extraordinary meeting, visits outside the schedule and per Conclusions. The extraordinary meeting, visits outside the schedule, and Conclusions shall not be held without the payment of such value. Daily fees are payable for each one of the Members.
Travels and general transportation of Members for the visits and/or any other location they need to go in order to comply with their duties as Members	The exact value of the cost incurred by the Member	Payable every time a Member incurs costs with transportation required to comply with his/her duty as Member. The Member shall confirm the cost of his/her transportation within 5 days, after the submission of the proof via Med Arb RB system or email for the parties and the chamber. The value is payable after the proof is submitted as defined above.  The Members may only charge the value of transportation available of lower cost, except in case of more than 2 hours of transportation. Even in such case, the Members cannot charge the most expensive value, only if the most expensive transportation is the single one available, or if all the parties agree to pay for such method of transportation.
Any other values the Members may incur in order to comply with their duties as Members	The exact value incurred by the Member	Costs according with article 5.3. of the Regulation of Dispute Settlement and Prevention Board of Med Arb RB. Payable every time a Member incurs the expenses required to comply with his/her duty as Member. The Member shall confirm the cost within 5 days, after the submission of the proof via Med Arb RB system or email for the parties and the chamber. The value is payable after the proof is submitted as defined above.  The Members shall always confirm that they endeavored their best efforts to incur the lowest costs possible and that the cost was actually required to comply with their duties as



Members.

- 3. All values defined by Med Arb RB or according with this Annex or Regulation shall be payable in Brazilian Reais (BRL), except in case of legal prohibition or decision otherwise by the chamber, cases in which Med Arb RB may apply a different agreement on fees and costs in another currency.
  - 3.1. In cases of statement of value in dispute in foreign currency, the conversion for Brazilian Reais shall be applied on the date of petition of the procedure in Med Arb RB, and the values shall be transferred in Brazilian Reais.
- 4. The Administration Fee and the first Monthly Fee of the Members shall be paid jointly with the execution of the Term of Board Establishment. According with article 5 of the Regulation, the Registration Fee shall be paid with the petition for Board initiation.
  - 4.1. A potential different method of payment shall be approved by Med Arb RB Chairman and shall be set forth in written in the Term of Board Establishment.
- 5. In the Term of Board Establishment, it shall be set forth how the parties may pay the costs.
- 6. The Members shall inform Med Arb RB, upon the acceptance, the method by which they will receive their fees and expenses reimbursement.
- 7. In case of receipt by an individual, the parties shall bear with the corresponding social security burden, or any other tax levied, which shall be collected by Med Arb RB (paying source), the tax authority in charge (Art. 22, I of Law 9.876/99). Likewise, the parties shall bear with the corresponding taxes and bank charges in case of transfer of values abroad.
- 8. Any and all payment made to the Members shall only be made by Med Arb RB after the due provisioning by the parties and by the fixed value deposited by them.
- 9. Omitted cases or specific situations shall be analyzed by the Med Arb RB Chairman.
- 10. The Med Arb RB Chairman is responsible for settling any matters regarding the interpretation and application of this table.
- 11. The invoicing and payment shall be made via deposit in account or platform; however, the Financial Department is in charge for issuing invoices or business invoices for payment of the Board costs.
- 12. Deposits shall not be accepted, except in cases of specific instructions and/or authorization submitted by the Secretariat of Med Arb RB, which shall indicate the corresponding account for the deposit. Authorized deposits shall be recognized by Med Arb RB after electronical submission of the proofs and its due identification.
- 13. According with the requirements of bank institutions, the CNPJ (National Register of Legal Entities) or CPF (Individual Taxpayer Registration) number is mandatory for bank slip issuance.
  - 13.1. For Parties resident abroad and, thus, with no CNPJ or CPF number, the invoicing shall be issued considering the international transfer as a method of payment for Med Arb RB.
- 14. The values in tables of article 1 and 2 of this Annex are corrected on a periodical basis, at the discretion of Med Arb RB Chairmanship, by IPCA or another index that may replace it.
  - 14.1. Only the values of the table shall be indexed by IPCA, and the values deposited before Med Arb RB as Members fees, in which it appears as fiduciary, shall not be indexed by IPCA and shall be deposited to the experts in due time when the services are concluded in the fixed valued deposited by the parties.
